Lincolnshire Show Regulations

LINCOLNSHIRE LIFESTYLE MARQUEE

Eligibility

Applicants for the Lincolnshire Lifestyle marquee must meet the following criteria:

- be based in Lincolnshire
- provide a copy of valid public liability insurance to the value of £5 million
- submit a completed risk assessment
- submit photos of your product(s)
- applications from food or drink exhibitors will **NOT** be accepted

Location

The Lincolnshire Lifestyle marquee is situated in the horticultural area, between the Floral Art marquee and the WI.

Exhibitors are requested to bring along a clear sign bearing their name to display within the confines of the allocated space. However, these must not be erected in such a way that they over-shadow a neighbouring stand or obscure the name signs of neighbouring stands.

Prohibited Items

The distribution, or sale of toy balloons (inflated or otherwise), replica weapons, kites, silly string or stink bombs is not permitted at the Show.

The use of drones for any purpose whatsoever is not permitted at the Show

The use of generators is not permitted at the Show. An electric supply can be ordered and paid for on the booking form.

Tickets and Passes

Each Exhibitor will be issued with two exhibitor tickets per day, a green “set up” pass for use on Tuesday 18 June, and a Lincolnshire Lifestyle parking pass for use on Show days. Access is via Gate 1 (A15). On Show days you’ll be directed in to the Lincolnshire Lifestyle parking area directly behind the marquee. Please be aware that space is limited.

Opening Times

Set up is from 8am on Tuesday 18 June and all stands must be set up by 6pm on that day. The Lincolnshire Show is open to the public between 8am – 6pm on Wednesday 19 & Thursday 20 June and all stands must be manned and open for business during these times. All goods must be packed away and removed from the marquee after 6pm on Thursday 20 June.

Security

Stewards will be available during set up and on Show days to offer support. There will be 24-hour security on site, but all items left in the marquee are the sole responsibility of the exhibitor. The Lincolnshire Agricultural Society cannot accept

responsibility for the individual security of individual stands or exhibits, or for the loss, damage, theft of any goods whatsoever.

Cancellation of Trade Stands

In the event of the cancellation of a trade stand, no refunds will be given.

Postponement or Abandonment

In the event of all or part of the Lincolnshire Show being postponed or abandoned, the Lincolnshire Agricultural Society would be under no liability in any way whatsoever in respect of any expenditure, loss, liability or damage sustained or incurred by the exhibitors. The Lincolnshire Agricultural Society would be entitled to retain all sums paid to them, or a percentage thereof to cover any expenses incurred in connection with the Show.

Application Process

All booking forms must be completed and returned with a picture of your products, full payment, completed risk assessments and a copy of your valid public liability insurance certificate (to cover 19 & 20 June 2019) to the value of £5 million. Space is sold on a strictly first come, first served basis.
