

OO Important Notes for ALL Equine Exhibitors

Equine Entry Pathway – Online

- Complete the online forms for your chosen class.
- Make your card payment.
- You'll receive a system response (this is not a record of Show Acceptance)

- Do check your bank statement to ensure the payment has left your account.
- **Show Acceptance** - you will receive a VAT Receipt from the Show Office via Email confirming entries and address for passes.
- Your Passes will be sent out in the post late May/early June

Horse of the Year Show Qualifiers:

Please ensure that the Exhibitor, Owner, Rider and Horse all have **HOYS User IDs**.

Cancellation Statement

There may be circumstances where the show has to be postponed, cancelled, abandoned or curtailed as a result of circumstances beyond the control of the Society, for example as a result of a security alert or as a result of inclement weather making it impractical to hold the Show. In such circumstances once any administration fees have been deducted, entry fees will be refunded, but the HOYS contribution is non-refundable. The Society will have no liability for loss or damage suffered by exhibitors or others.

Refund of Entries, Stables and other purchases Statement

- Entries not forward for any reason other than injury or illness will forfeit all entry fees.
- HOYS Contribution Fees and LAS Membership subscriptions are non-refundable.
- Stables bought through the Livestock & Equine Office are recognised Stables. Stables must not be sublet, (See Stable Section in the 01 Equine Regulations & Information)
- The Society will not accept responsibility for any exhibitor missing their class(es) and the respective entry fees will not be refunded.

OO Important Notes for ALL Equine Exhibitors

If exhibitor packs have already been despatched refunds will ONLY be considered if a vet/medical certificate is supplied to the Lincolnshire Agricultural Society office by 12 noon on Friday 24 June, stating that the animal/exhibitor is unfit to show, and provided that the exhibitor pack, containing all wristbands, vehicle passes etc. are returned unused to the Livestock & Equine Secretary by 12 noon on Monday 27 June 2022. Any claim received after **Monday 27 June 2022** will be invalid.

Equine Guidance Notes:

- **Administration Fee**

Online Entries are subject to a £2 administration fee

- **Class Entry Fees**

These are stated at the top of each Section. All entry fees are inclusive of VAT at 20%. (Any change in VAT rate will be applied from the due date.)

- **Prize Money:** to 5th place in most sections (stated above each section)
- **Rosettes:** to 6th place or 10th place (stated above each section)
- **Premium for Entries Forward:** Stated at the top of the following Sections:
Heavy Horse, Private Driving and Heavy Horse Turnouts

- **Stables**

Stables are £50/night (VAT inclusive) with special rate for Heavy Horse Turnouts – full Stable details appear in (01 Regulations & Information, 11)

Stables bought and sold anywhere other than through the Livestock & Entries Office will not be recognised.

Permanent stables available on a first booking system, first served.

Temporary stables to be provided by LH Woodhouse Stabling.

Please Note: Straw is not provided.

Stables used for Tuesday evening & Wednesday during the day must be left clean, skipped out. Failure to leave clean may result in a £50 fine.

OO Important Notes for ALL Equine Exhibitors

- **Wristbands**

Admission onto the Showground from the Horsebox Park will only be allowed for people wearing wristbands only (inc. riders & their associates).

Additional Equine Exhibitor Wristbands may be purchased ONLINE at a reduced rate, pre-Show – these will be sent out with your passes.

Please Note: if you do not have a wristband, then you will need to purchase a ticket at the **full gate price** on the day.

- **2023 Prize Schedule**

Equine Prize Schedules will be emailed to all 2022 exhibitors (with valid email addresses).

The Equine Prize Schedule will be available to view on the Lincolnshire Show website in Spring 2023.

- **Exhibitor Responsibility**

It is the responsibility of the exhibitor to ensure that they arrive on the showground in sufficient time for the commencement of their classes. Any ring timetables publicised are provisional and may be subject to change.

The Society will not accept responsibility for any exhibitor missing their class(es) and under no circumstances will fees be refunded.

Any Exhibitor, with a valid reason, wishing to withdraw an animal from a class or request a replacement animal in the same class needs to inform the Show office via email livestock@lincolnshireshowground.co.uk If the email is received either before or in the few days after the closing date for entries – this request will receive attention to determine the outcome either way.

After entries have closed and been catalogued Exhibitors are not entitled to a refund under any circumstances and no other new nominations or changes will be accepted.

OO Important Notes for ALL Equine Exhibitors

2022 Animal Health NOTE:

Within the last 12 months the animal should have had either the primary course of vaccinations or the appropriate booster to fully comply with the data sheet for that product. The interval between subsequent booster vaccinations in animals which has completed the primary course should not be more than 365 days.

The Primary Equine Influenza and Tetanus vaccinations are a compulsory requirement for all equines attending the Lincolnshire Show. 'If sufficient time has elapsed' after the Primary two vaccinations, these should be followed by their six month and yearly vaccinations. No equines should enter competitions within 7 days of an EI vaccination.

(This Rule may be subject to change from guidance from the FEI/BEF.

The requirement for the first 3 vaccinations is as follows: the first 2 vaccinations 21 - 92 days apart, a third booster between 150-215 days, and an annual booster vaccination within 365 days thereafter. No horse should enter competitions within 7 days of an EI vaccination. Foals should commence vaccinations at 6 months old.)

A valid vaccination history and certificate of vaccination must be available for inspection on request, failure to do so will result in being asked to leave the Showground.

Veterinary Team

All Livestock health & welfare concerns at the Lincolnshire Show are with the Veterinary Team from Rase Veterinary Centre, Market Rasen.

They are on the Showground from Tuesday midday and both days of Show.

The Veterinary emergency contact number is displayed in the Livestock Steward Office, the Equine Awards Office and with the Stable Security Team.

The LAS would like to thank the Team from Rase Veterinary Centre, Market Rasen for all their help during the year and at the Lincolnshire Show.

Show Regulations / Health Declaration (Equine)

Please note that by making entries into the Lincolnshire Show you are declaring:

- that the animals described in the entries are free from clinical signs of disease. You further declare that you will take all due precautions to prevent the animal(s) from being exposed to infectious or contagious disease previous to the Show.
- that you have read, understand and undertake to abide by the REGULATIONS & INFORMATION and the Conditions specific to all classes entered, as published in the Equine Prize Schedule.
